

We will have one of our portfolio managers call you to discuss your investments and objectives and help in the fund selection process. If there is a particular day and time that you would prefer this call, please make this note on or with your request.

Once your fund selections have been determined the partially completed RAF will be sent to you by Integra, for your completion. Your changes will then be implemented once we receive the completed and signed RAF back from you.
